**Attach** a current certificate and straight-line drawing prepared within 30 days prior to application by a registered land surveyor depicting the property lines and the structures containing any existing sexually oriented businesses or uses specified in paragraph 1.410(O)(2) of the Zoning Ordinance within 1,000 feet of the premises to be certified, as well as the boundary of any zoning district identified in paragraph 1.410(O)(1) of the Zoning Ordinance within one 500 feet of the premises to be certified.
