Forwarded by Supervisors Doyen and Teichmiller, Resolution 2015-38 **Requesting the Repeal of Paragraph 23 of Motion #520 to the State of Wisconsin 2015-2017 Budget Bill (SB21 & AB 21)** is put before the Board for discussion and possible action. The question put before the Board by this resolution indicates that Counties were already being informed of potential changes in the proposed state budget affecting NR115. The meeting minutes record that the resolution was adopted on an 18 to 1 roll call vote.

September 22, 2015

Forwarded jointly by the Legislative & Judicial Committee and the Zoning & Planning Committee, Resolution 2015-54 **Repeal Statutory Provisions Enacted in the State of Wisconsin 2015-2017 Budget Concerning Shoreland Zoning Standards** is put before the Board for discussion and possible action. The question put before the Board by this resolution asks the state to repeal shoreland zoning provisions enacted as part of Wisconsin State Budget Act 55. The meeting minutes record that adoption failed on a 9 to 11 roll call vote. A motion was then made by a member of the prevailing side to reconsider the resolution and to place it back before the Board for further action. Reconsideration failed on a tie vote.

**Repeal Statutory Provisions Enacted in the State of Wisconsin 2015-2017 Budget Concerning
Shoreland Zoning Standards**

Motion by K. Anderson, seconded by C. Hayes to adopt. At K. Anderson's request, the Clerk read this resolution aloud. The Chair permitted Glenn Schiffmann to address the Board. He spoke in opposition to the resolution. Discussion. A roll call vote returned the following results. 9 voted aye: K. Anderson, A. Bauman, W. Beversdorf, C. Hayes, P. Hennes, W. Otterpohl, C. Ritter, E. Teichmiller and V. Wiggerhauser. 11 voted no: M. Black, E. Bluthardt, G. Burkett, R. Caffarella, R. De Bruyne, A. Kunde, W. Maciag, T. Maulson, C. Rayala, M. Rogacki and K. Simac. Adoption failed. Immediately following the vote, T. Maulson called for a point of order and explained to the Chair that he had misunderstood the question. He requested that he be allowed to change his vote from a no to an aye. The Corporation Counsel advised that the roll call vote was cast and that his vote was recorded and could not be changed. She further advised that as he had voted with the prevailing majority, he could move to reconsider the resolution, thereby placing it again before the Board for deliberation. Motion by T. Maulson, seconded by K. Anderson to reconsider Resolution 2015-54 and to place it back before the Board for additional deliberation. Discussion. A roll call vote on the motion to reconsider returned the following results. 10 voted aye to reconsider: K. Anderson, A. Bauman, W. Beversdorf, M. Black, C. Hayes, P. Hennes, T. Maulson, C. Ritter, E. Teichmiller and V. Wiggerhauser. 10 voted no in opposition to reconsideration: E. Bluthardt, G. Burkett, R. Caffarella, R. De Bruyne, A. Kunde, W. Maciag, W. Otterpohl, C. Rayala, M. Rogacki and K. Simac. Motion to reconsider failed on a tie vote.

November 16, 2015

Forwarded by the Zoning & Planning Committee, Resolution 2015-70 **Re: Moratorium on Land Division Within the Shoreland Area of Vilas County** is placed upon the November 16, 2015 County Board agenda. The question put before the Board by this resolution adopts a 6-month moratorium on land division within the shoreland area, in response to provisions contained in NR115 as revised by Wisconsin Budget Act 55. This resolution was removed from consideration before the Board at the meeting, by the Chairman of the Zoning & Planning Committee.

Moratorium on Land Division Within the Shoreland Area of Vilas County

Zoning Committee Chairman K. Anderson requested recognition by the Board Chair, and after being given the floor, announced that the Zoning and Planning Committee was taking a different direction in regards to the minimum lot size and land division issue. He stated that the committee would immediately begin work to amend the subdivision ordinance. He also stated that public hearings concerning ordinance amendments would be held in several townships. He expects that the Board will be asked to adopt subdivision ordinance amendments no later than March, 2016. After making the above statements, he withdrew Resolution 2015-70 from consideration by the County Board.
