## MINUTES TOWN HALL FEASIBILITY COMMITTEE: JUNE 28, 2007

1. **Call To Order:** The chairman noted that this was a duly called meeting in accordance with the Wisconsin Open Meeting Law. The meeting was called to order by chairman, Fred Radtke, at 8:00 A.M. in meeting room #4 of the Community Center.
2. **Roll Call:** Fred Radtke, Jack Gardner, Verdelle Mauthe, Leon Anderson, Tom Martens.
3. **Approve Agenda:** Motion Gardner seconded Anderson that the agenda be approved as posted. Approved.
4. **Travel to Land O Lakes to View Remodeled Building:** Mr. Radtke drove the committee to the Land O Lakes town hall in the Prime Timers Van to view the remodeling that had been done.
5. **Tour Remodeled Building:** Mike Stopczynski, Land O Lakes town supervisor, and Dan Balog, town chairman, conducted the tour of the town hall.
6. **Return to St. Germain Community Center Room #4:** The committee returned to St. Germain at approximately 10:00 A.M.
7. **Review Finding of Visit:** The committee generally liked what had been done in Land O Lakes. The town record room had been recently constructed out of concrete block in the old boiler room. Our Red Brick Schoolhouse would have a similar room in the old coal bin. Mr. Martens felt that the vinyl windows that had been used in Land O Lakes did not fit in well with the rest of the building. He also felt that the paneling and lighting that were used were not very fitting for a building that was to be made historically correct.
8. **Propose Future Meeting Agendas:** Mr. Radtke stated that he would like the agendas to be from suggestions by the entire committee, not just from himself. Mr. Radtke also suggested that the committee also tour the Sayner town hall. Mr. Radtke also noted that he would like to invite William Kelly, the engineer who prepared the study for Red Brick Schoolhouse Restoration, Inc., to one of the committee meetings.
9. **Citizens Concerns:** There were none.
10. **Committee Concerns:** Mr. Radtke stated that each committee member should try to come up with a new name for the committee. He felt that the name should not include anything about Red Brick or restoration.
11. **Future Meeting Date:** The next regular committee meeting will be held on Monday, July 16, 2007 at 3:00 P.M. in meeting room #4 of the Community Center.
