WHEREAS, the public interest requires that a portion of Hiawatha Avenue in the Town of St. Germain, shown on the map attached hereto and incorporated herein by reference as Exhibit A, be discontinued and vacated; and

WHEREAS, this portion of the road is more particularly described in Exhibit B attached hereto and incorporated herein; and

WHEREAS, this resolution was introduced before the Town Board of the Town of St. Germain on July 21, 2005, and

WHEREAS, the Notice of Pendency of Application to vacate the said portion was filed with the Register of Deeds for Vilas County on July 5, 2005; and

WHEREAS, the Notice of Hearing was published in the official Town newspaper on July 25, 2005, August 2, 2005 and August 9, 2005; and

WHEREAS, a copy of said Notice was served or mailed more than 30 days prior to the hearing in the manner prescribed by law on the owners of all the frontage of the lots and lands abutting upon the portion of said road to be discontinued; and

WHEREAS, a public hearing was held before the Town Board of St. Germain on August 30, 2005 and no written objection to said discontinuance and vacation in accordance with sec. 66.1003, Wi. Stats. was filed with the Town Clerk.

NOW, THEREFORE, in accordance with the authority vested in the Town Board by sec. 66.1003, Wi. Stats., the Town Board of the Town of St. Germain hereby resolves as follows:

<u>Section 1.</u> Portion of Hiawatha Road Vacated. The portion of Hiawatha Avenue, Town of St. Germain, Vilas County, Wisconsin, shown on Exhibit A attached hereto an incorporated by reference, and more particularly described in Exhibit B, is hereby vacated and discontinued.

<u>Section 2.</u> Clerk Duties. The Town Clerk shall record a certified copy of the Resolution with the Vilas County Register of Deeds.

<u>Section 3.</u> **Official Map Amendment.** If necessary, any official Town map shall hereby be amended to be consistent with this Resolution.
